

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to JYB Corp DBA Siteraptor.com, hereby referred to as the company, and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references the company. The company is an online marketing agency. By using the the company, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Site Raptor may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase the companies products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

The company collects and uses your personal information to operate its website(s) and deliver the services you have requested.

The company may also use your personally identifiable information to inform you of other products or services available from Site Raptor and its affiliates.

Sharing Information with Third Parties

The company does not sell, rent or lease its customer lists to third parties.

The company may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Site Raptor, and they are required to maintain the confidentiality of your information.

The company may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Site Raptor or the site; (b) protect and defend the rights or property of Site Raptor; and/or (c) act under exigent circumstances to protect the personal safety of users of Site Raptor, or the public.

Tracking User Behavior

The company may keep track of the websites and pages our users visit the company website in order to determine what company services are the most popular. This data is used to deliver customized content and advertising within the company to customers whose behavior indicates that they are interested in a particular subject area.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by the company. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Site Raptor website.

Use of Cookies

The company website may use "cookies" to help you personalize your Online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if the company personalizes client pages, or registers with company site or services, a cookie helps the company to recall your specific information on subsequent visits. - SSL Protocol

Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. As a result, while we strive to protect your personal information, you acknowledge that: (a) there are security and privacy limitations inherent to the Internet which are beyond our control; and (b) security, integrity, and privacy of any and all information and data exchanged between you and us through this Site cannot be guaranteed.

Children Under Thirteen

External Data Storage Sites

We may store your data on servers provided by third party hosting vendors with whom we have contracted.

We will notify you about significant changes in the way we treat personal information by sending a notice to the primary email address specified in your account, by placing a prominent notice on our site, and/or by updating any privacy information on this page. Your continued use of the Site and/or Services available through this Site after such modifications will constitute your: (a) acknowledgment of the modified Privacy Policy; and (b) agreement to abide and be bound by that Policy.
